WHY IS THE COLORADO QUICK CARE CARD NEEDED?

Maternal morbidity and mortality remain urgent public health challenges in Colorado and across the United States. Serious complications can occur during pregnancy and throughout the first year postpartum, often outside traditional obstetric settings. Many individuals seek care in emergency departments, urgent care clinics, or from first responders who may not have immediate access to pregnancy-related health information. Early recognition of warning signs and clear communication across care teams are critical to preventing severe outcomes.

Data from Colorado's [Maternal Mortality Review Committee](#) show that a significant proportion of maternal deaths occur in the postpartum period, frequently outside the birth facility and beyond traditional obstetric care. Nationally, the [CDC](#) reports that approximately 57% of maternal deaths occur between 7 and 365 days postpartum.

The Quick Care Card addresses this gap by ensuring birthing people, first responders, and healthcare teams have shared, easily accessible information at the point of care.

Developed by the [Colorado Perinatal Care Quality Collaborative](#), the program includes an alert card with QR codes, educational resources, and key warning signs of pregnancy and postpartum complications. The initiative supports patient safety, continuity of care, and awareness across emergency response systems.

Rural Impact

According to the [March of Dimes](#) 2025 report, 37.5% of Colorado is classified as a maternity care desert, meaning no obstetric providers or services are available. This gap highlights the need for clear communication between patients and non-maternity providers to ensure timely, appropriate care. The Quick Care Card is designed to help bridge that gap.

WHAT IS THE COLORADO QUICK CARE CARD?

The Colorado Quick Care Card is designed to support patients and healthcare providers in recognizing and responding to pregnancy and postpartum complications. It serves as a practical tool to improve communication, patient education, and access to critical resources during pregnancy and the postpartum period. Key benefits of providing your patients with the Colorado Quick Care Card include:

- **Equitable** – Low-cost, easy to distribute, and accessible for hospitals across urban, rural, and frontier communities
- **Consistent** – Aligns with familiar medical communication tools such as medication cards, chronic disease action plans, allergy alerts, and blood type cards
- **Comprehensive** – Includes key physical, mental, and behavioral health warning signs related to pregnancy and the postpartum period
- **Action-Oriented** – QR codes link to trusted, up-to-date patient and provider resources for rapid access to additional information and support
- **Portable** – Designed to be kept with a patient’s ID and insurance cards, making it easy to access during any healthcare encounter and supporting continued use beyond the initial 6–12 week postpartum period. Use is recommended for up to 12 months postpartum, when the risk of pregnancy-related mortality remains elevated

By providing the Colorado Quick Care Card to your patients, your team will:

- Standardize education on pregnancy and postpartum warning signs
- Help patients quickly access trusted community resources and support
- Provide healthcare providers with a quick visual cue that a patient is pregnant or postpartum
- Ensure healthcare teams can easily access up-to-date, evidence-based perinatal care protocols

The Colorado Quick Care Card helps strengthen patient safety, communication, and continuity of care throughout pregnancy and the full postpartum year.

Pregnancy & Postpartum Quick Care Card

Keep this card with your ID or insurance card. If you need medical care during pregnancy or in the **first year** after having your baby, please show this card to your doctor, midwife, nurse, or paramedic.

Having a baby can increase risks for medical issues, mental health concerns, substance use, and domestic violence. If something feels off, [trust yourself and get help](#).

EMERGENCY CARE PROVIDERS:
Helpful algorithms and information on treating pregnancy & postpartum complications



PARENTS AND FAMILIES:
Important information and support resources during and after pregnancy

Immediately call 911 or go to the Emergency Room for ANY of these issues:

- Chest pain or difficulty breathing
- Seizures
- Thoughts of harming yourself or your baby
- Feeling extremely sleepy, weak, or passing out
- Blood pressure higher than 160/110
- Fear for your safety or your baby’s safety

Call or visit your doctor or midwife for these medical concerns:

- Blood pressure higher than 140/90
- Fever higher than 100.4 degrees
- Bleeding that fills a pad in less than 1 hour or clots larger than an egg, when postpartum
- Blurred vision or headache that does not get better with meds, fluids, or rest
- Redness, swelling, heat, discharge, or bad smell in your stitches, vaginal discharge, or breasts
- Any vaginal bleeding when pregnant
- New or uncontrolled pain
- Having trouble pooping or pain when peeing
- Swelling, tenderness, redness, or heat in your legs

Call your doctor, midwife, or therapist/counselor for these mental health concerns:

- Feeling sad, worried, angry, anxious, or guilty. Especially if it makes it hard to sleep, take care of yourself, or your baby
- Using or considering using substances (vaping/cigarettes, marijuana, alcohol, opioids, or other) to cope

PATIENT AND FAMILY RESOURCES

Patients must understand the purpose of the Quick Care Card. Use the resources in this section to educate patients and families on how and when to use it. We recommend distributing the patient flyer alongside the Quick Care Card to reinforce this information.

You will also find several formatting options for printing the Quick Care Card at your facility. Select the version that works best for your team's workflow. If your patient doesn't carry a wallet, suggest they carry the card in their phone case, use the sticker version on their phone case, or save the Colorado Quick Care Card website to their favorites on their phone.

PUTTING THE QUICK CARE CARD INTO PRACTICE

The following pages provide information and resources to support the implementation of the Colorado Quick Care Card at your site. They also include actionable steps to help ensure the card is consistently distributed and that patients receive education on how and when to use it.

How will we educate our team?

- Share in huddles, meetings and email
- Post flyers in work areas
- Include in onboarding or annual education
- Review when and how to use the card

How will we check progress?

Check staff awareness in 3-6 months, then annually

How will patients receive it?

- Decide who gives the card
- Decide when it is given
- Keep cards stocked in key areas
- Add a short script for staff

How will we check progress?

Periodically confirm cards are being handed out as planned

How will we make it accessible?

- Offer in multiple languages
- Use plain language to explain
- Support with interpreter services
- Provide print and digital options

How will we check progress?

Review whether materials are accessible to your patient populations

How will we communicate across care settings?

- Share with local EMS, ED, outpatient and OB teams
- Identify a contact champion in each setting
- Review during cross-team meetings

How will we check progress?

Check in periodically to identify gaps and improve coordination

QUICK CARE CARD ACTION PLAN

Start here:

- Choose where Quick Care Cards will be stored
- Decide who will distribute cards
- Train staff on Quick Care Cards using multiple methods (written, verbal, visual)
- Make materials easy to access
- Share the Quick Care Card with partner teams (ED, EMS, outpatient)
- Check back in 3-6 months to ensure Quick Care Cards are being distributed

POSTPARTUM ALERT BANDS

Postpartum alert bands, such as the [Association of Women’s Health, Obstetric and Neonatal Nurses \(AWHONN\) POSTBIRTH Alert Bands](#), are visual safety tools that quickly identify patients at increased risk for serious postpartum complications.

These color-coded wristbands support rapid recognition, standardized communication, and timely escalation across care settings, including triage, the emergency department, and inpatient units.

You may see different versions and colors of these wrist bands. As many sites around Colorado have independently done them as Quality Improvement projects.

CPCQC recommends prioritizing the implementation of the Colorado Quick Care Card first, as it is the most equitable and accessible resource for hospitals of all sizes and resource levels. If teams have the capacity to implement alert bands in addition to the card, we recommend using [AWHONN’s POSTBIRTH Alert bands](#), as they are widely available and nationally recognized.

Using standardized tools, such as the Quick Care Card, helps promote consistency communication, equitable care, and timely response to maternal warning signs.



TOOLKIT SUMMARY

The Colorado Quick Care Card Toolkit is a practical strategy to reduce preventable pregnancy and postpartum morbidity and mortality in Colorado.

By equipping birthing people with clear information about warning signs and connecting emergency providers to concise, actionable guidance, **the initiative strengthens communication at critical moments**—particularly when care occurs outside the birth facility.

Together, these efforts ensure that **no pregnancy or postpartum concern is dismissed, no warning sign is overlooked, and every birthing person has a clearer, safer path to timely care.**
